Whereas IT REPRESENTS MORE THAN 4,000 MUSICIANS FROM 52 MAJOR SYMPHONY ORCHESTRAS THROUGHOUT THE UNITED STATES AND IS A PLAYERS' CONFERENCE OF THE AMERICAN FEDERATION OF MUSICIANS; AND

Whereas WHILE CELEBRATING THE GREAT HISTORY OF SYMPHONIC MUSIC, ICSOM SEEKS TO PREPARE FOR AN EVEN GREATER FUTURE BY CHAMPIONING NOT ONLY THE INTERESTS OF ITS MEMBERS, BUT THE CAUSE OF SYMPHONIC MUSIC AND BROAD SUPPORT FOR THE ARTS THROUGHOUT THE NATION; ITS MAIN MISSION IS TO FACILITATE COMMUNICATION AMONG MEMBER ORCHESTRAS AND ALL MEMBERS OF THE GREATER MUSICAL COMMUNITY; AND

Whereas ICSOM IS HOLDING ITS ANNUAL CONFERENCE IN LOS ANGELES AT THE BONAVENTURE HOTEL FROM AUGUST 25-28, 2014, THE THEME IS "THE ART OF ADVOCACY," AND ITS DELEGATES ARE EXTENDED A SINCERE WARM WELCOME FOR THIS EVENT;
